TERMS AND CONDITIONS

1. The promoter of the Competition is the Australian Turf Club Limited (ABN 81 148 157 288) of Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61 2 9663 8400 (**Promoter**).

2. The Competition is a game of skill not chance. The Competition will be judged by a judging panel consisting of two judges selected by the Promoter (**Panel**).

3. Rules on how to enter the Competition form part of these Terms and Conditions of entry. The Rules can be found at <http://www.australianurfclub.com.au/fun-off-track> (Website). By entering the Competition or accepting a prize, entrants agree to be bound by these Terms and Conditions.

4. The Competition will be conducted on social media (Instagram and Twitter) on Longines Golden Slipper Day, Saturday 21 March 2020 between 11.00am AEDT and 5.00pm ("**Longines Golden Slipper Day**").

5. In order to enter the Competition, entrants must post a photo of their Longines Golden Slipper Day celebrations at home or away from the track. Photos must be posted on Instagram, Facebook or Twitter and must tag: @atc_races @7horseracing #FunOffTrack

6. By posting their photo and tags as above, entrants agree to have their photo displayed on Channel 7's raceday broadcast and/or on ATC social media, and/or 7 Racing social media at the Promoters discretion.

7. Entrants will be judged according to the guidelines;

- a. A depiction of celebrating Longines Golden Slipper Day away from the track.
- b. Effort put into the creativity of the entrant's Longines Golden Slipper Day celebrations away from the track.
